OT respects your right to privacy and will not make your designs avail able to anyone without your express written consent.

LOGO SET UP FEE: Ocean-Tec USA charges Logo Screen Charges. See Pricing. If Ocean-Tec needs to convert file to vector the additional charge for this service is \$30, but it is usually more advantageous for client to outsource vectoring.

PAYMENT TERMS: Customers are required to provide a valid re-sale tax certificate or tax identification #. Payments can be made by check, credit card, ACH or wire transfer. We add a convenience fee for all credit card payments: 2% for Visa and Mastercard, 3% for American Express.
